DNR, consulting, industry, and Soil and Water Conservation District foresters are available to help you meet your goals by writing a stewardship plan for your property.

You need to work with an approved stewardship plan writer if you intend to enroll your land into the Sustainable Forestry Incentive Act (SFIA) or 2c Managed Forest Land property tax programs.
